TAX FREE DELIVERY ELIGIBILITY & GUIDELINES FOR YACHTS

If your vessel is commercially registered then you may be eligible to receive your goods tax-free. Read on to find out if you match the required criteria!

You must be able to tick all the following boxes:

- ✓ THE YACHT IS COMMERCIALY REGISTERED
- ✓ THE YACHT HAS A PERMANENT CREW
- ✓ THE YACHT IS USED FOR COMMERCIAL PURPOSES ONLY
- ✓ THE YACHT IS AT LEAST 15M LONG
- ✓ THE YACHT MUST EXIT FRENCH WATERS FOR AT LEAST 70% OF TRIPS PER YEAR
- ✓ NOT MORE THAN 50% OF CHARTERS IN THE PREVIOUS YEAR WERE STATIC
- ✓ THE GOODS PURCHASED ARE NOT FOR A STATIC CHARTER SUCH AS THE CANNES FILM FESTIVAL OR MONACO GP
- ✓ THE AMOUNT PURCHASED IS IN KEEPING WITH THE DURATION OF THE CHARTER AND ITS NUMBER OF GUESTS
- ✓ THE YACHT WILL LEAVE PORT WITHIN 48 HOURS FOLLOWING DELIVERY

If you ticked all of the above then we will be delighted to assist you.

If you would like to receive your wines tax free then please let us know when you place your order.
We cannot request the removal of tax on goods already delivered.

All you need to do is let us know where & when you require delivery, and send us the following documents at least 48 hours prior to your desired delivery time:

- CERTIFICATE OF COMMERCIAL REGISTRATION FOR YOUR VESSEL
- A COPY OF THE SIGNED CHARTER AGREEMENT
- AN UP-TO-DATE CREW LIST
- A SIGNED COPY OF THE COMMERCIAL ACTIVITY DECLARATION, STAMPED AND SIGNED BY THE CURRENT CAPTAIN (PLEASE ASK IF YOU REQUIRE A BLANK COPY)

Deliveries can only be made during Customs opening hours and following receipt of their approval. This means deliveries can usually only be made 09.00-12.00 or 14.00 – 17.00, Monday – Friday.

No return of goods can be accepted once the delivery has cleared Customs.

Goods delivered tax free cannot legally be taken off board without going through an import tax procedure, involving paying customs charges as well as VAT.

Customs do reserve the right to board the vessel at the time of delivery and at any point thereafter to ensure that all delivery requirements have been met.

Please note that the invoice must be issued in the name of the company as it appears on the certificate of commercial registration.

TAX FREE DELIVERY ELIGIBILITY & GUIDELINES FOR PRIVATE JETS

Our headquarters in Nice is a stone's throw from the International Airport. We work closely with the Private Jet Terminal to ensure that our deliveries are smooth and stress-free.

We can provide tax-free deliveries of wine, Champagne & spirits to your Private Jet if you are able to meet the following criteria:

- ✓ YOUR FLIGHT DESTINATION IS OUTSIDE OF THE EU
- ✓ YOUR FLIGHT IS DIRECT AND DOES NOT INCLUDE A STOP-OVER
- ✓ YOUR CAPTAIN CAN PROVIDE US WITH THE AIRCRAFT TAIL NUMBER AND THE DETAILS OF YOUR HANDLING AGENCY ONSHORE

Please let us know if you require a tax-free delivery at least 48 hours in advance of your flights departure. We cannot request the removal of tax on goods already delivered.

Deliveries can only be made during Customs opening hours and following receipt of their approval. This means deliveries can usually only be made 09.00-12.00 or 14.00 – 17.00, Monday – Friday.

No return of goods can be accepted once the delivery has cleared Customs.
